STEP SIX WERE ENTIRELY READY TO HAVE GOD REMOVE ALL THESE DEFECTS OF CHARACTER.

Love to the Fullest-and Live! A Miracle of 5th and 6th Step Transformation

I floundered like an unanchored vessel in violent seas, crashing against razor-sharp rocks, when safe harbor existed to lovingly shelter me and had been there all along—I simply had to open my eyes to its warm and welcoming turquoise colors and use my ears to listen for its music of tranquil waters.

As an artist, that statement best reflects how I see and feel about the comprehensive transformation which has taken place in my life because of God and A.A. My thorough Steps 5 and 6 actions played a crucial role in the revival, or perhaps more correctly the regeneration, of my perspective and attitude. I say crucial because it erased the years of guilt I needlessly carried to beat myself with as a proverbial self-imposed whip and transformed it into an asset to share with others.

My experience seemed long in coming but erupted suddenly as if it were a geyser, launching me over the "invisible wall" after two significant events. This is a short story of changes—of my transition—and the fact there was buried deep within my subconsciousness a loathing with which I used to batter myself. You see, years into my sobriety a piece of my original nemesis called Terminal Uniqueness remained within, and it's just that I didn't know it—yet. Here is what happened to me.

I remember in my first A.A. meeting looking at the Steps and Traditions posted on the wall, but the only thing I understood and wholeheartedly agreed with was Step One and I thought Step Five looked exciting, because I believed I was going to finally, finally have a chance to get my say about my life and my problems! I'd been plagued by issues of self-pity, loneliness, despair, guilt, unacceptance, fear, anger, resentment, jealousy, laziness, negativity, self-reliance, procrastination, perfectionism, unrealistic expectations, intolerance, very low self-esteem, and I just didn't like myself.

I had become a professional self-loather. It began in my young family life, and there isn't enough room here to explain why things were as they were. The important fact is, I became psychologically self-abusive in response, and my prejudicial attitude proved to be nothing more than a destructive waste of time.

However, what was my solution? I looked for love and affection in all the wrong places, becoming pregnant at fifteen during the mid-1970s. When I admitted the truth after six months' time, it was a social embarrassment my parents weren't about to endure. I was hastily whisked off to NYC to a figurative butcher shop—so the situation didn't end well for anyone. It was a horrible experience, and I felt guilty deep within my heart that I wanted a permanent erasure, just like my parents. But then I saw myself as a murderer.

That experience was a major element in the perfect storm for my perspective as unacceptable, because I was seeking an unattainable perfection which could "fix" me forever. I was afraid of my feelings, hated being a social misfit, blamed myself into self-pity, and despised being so "defective" or imperfect. I never was told, nor had I once

ever realized or understood, I was simply human. And, although God forgave me long ago for the teen pregnancy, I never realized I'd not forgiven myself. But, nothing happens in God's world by mistake, does it.

It was an ordinary A.A. lunch meeting on an ordinary day. There wasn't any indication that something profound would happen—until it did. I truly believed that never, not in a million years, would I ever encounter another person who had nearly an identical experience as I regarding their teen pregnancy. Then, a woman about my age began to share. As each sentence poured out, she talked about her same experience at about the same age as I had been, during the same time period—and she ended up in NYC just like me, experiencing the same bad results. Suddenly, I felt overwhelming waves of realization that I singled myself out in a Terminally Unique fashion, and it shook me to my core!

However, it still took months before what happened could resonate. Then, one evening I attended a speaker meeting I'd not been to before. I was somewhat familiar with the speaker, but little did I know a part of that person's story would bring me to my knees so profoundly that I had to walk out in the midst of their testimony! It involved a family tragedy in the speaker's life, and although the situation and circumstances were nothing like mine, children were a vital component.

But, what had I felt? A panic-type emotion that welled up inside me which I didn't even know existed, and it took my breath away! I'd been suppressing the truth regarding my teen mistake, my guilt, and my self-imposed punishment because I hadn't let go of the singularity which was causing me to stand in the way of my own progress. I was a self-destructing nemesis with a subconsciously-ingrained warped attitude about myself! Now...who was I to be playing God? At the first opportunity, I openly shared with that speaker what happened and did all I could to make things right.

The point is, God used those people to make His point. I didn't understand what was wrong with me until after this pivotal situation presented itself, and the dust settled. However, when it had time to fully resonate, my Terminally Unique attitude had disappeared!

As a result, what changed? I transitioned from fantasies inside my head and self-justifications into having a realistic, sane view of myself and able to take corrective actions for progress. And, I went from despair, self-pity and self-loathing to self-respect, being responsible and accepting myself as a child of God, equal in His eyes, and worthy of His grace and Love. When I stopped living in my thinking and began to deal with my feelings, I went from infinite What ifs? to the What IS. And once I discovered my deeply-buried self-prejudice, soul-searching honesty sparked effective change in my Spiritual program, and I could live at peace with myself. But, it was God using two, seemingly inconceivable-to-me events to ignite the fire of doom to my Terminal Uniqueness.

Therefore, this story of transition all comes down to Hope. Hope is the very first thing I found in AA; Hope is what I've found in the Steps; Hope is what I've found in forgiveness, including self-forgiveness; and Hope is what I find today. Now, I seek to live like the magnificent St. Francis' Prayer suggests—in love, gratitude, kindness, compassion, understanding, and doing the next right things.

And so, I close with a message of Hope and encouragement that a thorough Steps 5 and 6—and I had to recognize both conscious and subconscious facts—may provide you with fresh, new energy for change just as it did for me. May the God of your understanding bless and care for

you, today. Love to the fullest, and live!

TRADITION SIX

AN A.A. GROUP OUGHT NEVER ENDORSE, FI-NANCE, OR LEND THE A.A. NAME TO ANY RE-LATED FACILITY OR OUTSIDE ENTERPRISE, LEST PROBLEMS OF MONEY, PROPERTY, AND PRESTIGE DIVERT US FROM OUR PRIMARY PURPOSE

AA doesn't affiliate with any other organizations because we can't be responsible for what other organizations are doing. Tradition six is linked to Tradition five, that our primary purpose is to help the suffering alcohol. There are a lot of great recovery services and we are free to associate with any of them on an individual level, we can also bring AA meetings to treatment centers and other facilities but when doing that we must only do it as representatives of Alcoholics Anonymous, not as AA members and whatever the organization is. This could potentially confuse our message to the newcomer and tie AA to whatever that organization is doing.

AA also doesn't oppose any other groups or causes (Tradition ten), even if I might think some other recovery based

institution isn't doing it right that doesn't mean that AA is against what they are doing. AA doesn't have an opinion on what other organizations are doing. Personally, I find this is a better way to view life in general.

I tend to be very opinionated and judgmental, but if I can let other people and organizations be who they are, I find I'm a lot more at peace with the world around me. Surprisingly, most of these groups haven't yet asked my opinion on what I think they should be doing, so I can just let them carry on however they see fit, and I can also believe that they are doing what they think is best. This even works at my job, with the government, and other institutions I have to deal with. I just remember that I'm not really responsible for how they run things. I can keep myself right-sized by remembering that I'm just an employee or customer, a taxpayer or a voter, and that's it! It takes a lot of responsibility off me.

Life is a lot simpler when we can just be responsible for what we are doing, and that's the main point of this Tradition.

CONCEPT SIX

ON BEHALF OF A.A. AS A WHOLE, OUR GENERAL SERVICE CONFERENCE HAS THE PRINCIPAL RESPONSIBILITY FOR THE MAINTENANCE OF OUR WORLD SERVICES, AND IT TRADITIONALLY HAS THE FINAL DECISION RESPECTING LARGE MATTERS OF GENERAL POLICY AND FINANCE. BUT THE CONFERENCE ALSO RECOGNIZES THAT THE CHIEF INITIATIVE AND THE ACTIVE RESPONSIBILITY IN MOST OF THESE MATTERS SHOULD BE EXERCISED PRIMARILY BY THE TRUSTEE MEMBERS OF THE CONFERENCE WHEN THEY ACT AMONG THEMSELVES AS THE GENERAL SERVICE BOARD OF ALCOHOLICS ANONYMOUS.

This is another concept that is about the importance of delegated responsibility. A.A. is owned by the individual members of A.A. which make up our local groups, but it would be impossible for the individual members or local groups to make all the decisions necessary to do all the things A.A. World Services does, so the groups vote in representatives (GSR's) to represent them at district meetings and area assemblies, each area elects a delegate to represent them and that delegate is part of the General Service Conference. There are 93 areas in North America and each has a delegate, you can see the map at aa.org, and they come together with the General Service Board, there are 21 trustees on the board who are elected by board, and they all meet once a year to make decisions about A.A. World Services. The things they discuss are

about what literature to publish, planning the international conference, regional forums, and a lot of other A.A. related issues.

Bill W. explains our structure this way in the chapter on concept six in Twelve Concepts for World Service: "From top to bottom, our whole service structure indeed resembles that of a large corporation. The A.A. groups are the stockholders; the Deligates are their representatives or proxies at the 'annual meeting'; our General Service Board Trustees are actually the directors of a 'holding company.' And this holding company, the General Service Board, actually owns and controls the 'subsidiaries' which carry on our active world services."

If you're still reading this you might be wondering "what does all this bureaucratic BS have to do with me?" How do I know you're thinking that? Because you're a self-centered alcoholic like me! If you're not thinking that you've probably been involved in service at district and area and are only reading this shaking your head thinking, "there is so much more you could say about our upside down triangle!" The point is, in order for our fellowship to exist and keep reaching more suffering alcoholics, we need a structure of service representatives who help keep our doors open and our literature being published. We should be thankful for all these members of A.A. and non-alcoholic friends of A.A. who make that happen and do whatever we can to support them.

June 1: 1949 - Anne Smith, Dr. Bob's wife, died.

June 5: 1940 - Ebby Thatcher took a job at the NY Worlds

June 6: 1979 - AA gave the two-millionth copy of the Big Book to Joseph Califano, then Secretary of Health, Education, and Welfare. It was presented by Lois Wilson, Bill's wife, in New York.

June 7: 1939 - Bill and Lois Wilson had an argument, the first of two times Bill almost slipped.

June 10: 1935 - The Dates that is celebrated as Dr. Bob's last drink and the official founding Dates of AA.

June 11: 1945 - Twenty-five hundred attend AA's 10th Anniversary in Cleveland, Ohio.

June 16: 1938 - Jim Burwell, "The Vicious Cycle" in Big Book, had his last drink.

June 21: 1944 - The first Issue of the AA Grapevine was published.

June 25: 1939 - The New York Times reviewer wrote that the Big Book is "more soundly based psychologically than any other treatment I have ever come upon."

June 26: 1935 - Bill Dotson. (AA #3) entered Akron's City Hospital for his last detox and his first day of sobriety.


ALR, a men's recovery house in Prattville, still has some slots available on Sunday nights at 6:00 p.m. for people to host workshops on a variety of different recovery topics.

New things coming with Mt. Meigs. Jeremy spoke to the volunteer coordinator, and she was very excited about the possibility. There is a more extensive background check for Mt. Meigs because it is working with juveniles. Jeremy is having a face-to-face meeting with the coordinator and her supervisor to discuss what it might looking like and what AA has to offer.

No changes with State facilities. But we don't have the volunteers to go regardless. It is the goal of the committee to focus on county jails currently until we have the ability to do more. We don't want to commit to things we can't provide.




