- We negotiated down available options regarding certain costs to the Assembly such as: storage building fee contracts, consolidated equipment, cost savings for processing contributions.
- Area Finance Committee has provided accurate information for the Assembly to make an informed decision.





They are a by-product of surrender to God and service to others. "How do I do that?" You might ask. Is it really possible to live a totally surrendered life all of the time? Can I really have a life that is focused on serving others instead of myself and still be happy?

Yes you can. You can live your life surrendered to God, as you understand Him, as long as you are willing to repeatedly practice Steps Six and Seven. This may not look like the life of ease and serenity that we initially imagine when we first heard the promises in a meeting, but it is no less miraculous. We don't have to delude ourselves by thinking we won't have any problems, but we know that whatever problems we face can be met with confidence that we will get through them.

I was talking with another A.A. the other night and he reminded me that, "the only way out is through." So whatever I'm dealing with, whether it's the death of a loved one, my kids acting up, financial problems, or health issues, I know God has got it figured out already. I don't have to know what that plan is, I just have to be willing to do the right thing and trust that it will turn out exactly the way it is supposed to. Sometimes I don't know what to do, what I have learned from others in the program with a lot more experience than me is that I often don't have to do anything in those situations. I ask for direction and wait until I have some clear guidance. When I do that, everything seems to work out exactly the way it is supposed to. When I try to control the situation, that's when my character defects show up. So I really do need to let go and let God. The more I surrender, the more peace I have.
