

#### HISTORY FEATURE

#### **EARLY PERCEPTION OF ALCOHOLISM**

Throughout domestic history, numerous descriptions and "causes" of alcoholism have been offered with



many including a lack of morality. A common belief was that alcoholics could not be helped. The first major American document on the effects of alcoholism was "An Inquiry Into the Effects of Ardent Spirits Upon the Human Body and Mind," by Dr. Benjamin Rush (1745-1813). Published circa 1785, it states that this 'Odious Disease' leads to madness and death. He provides some random suggestions and mentions a few cases of abstinence.

Changes in this thinking started occurring in the early 1800s. Prior to this, many believed alcoholics could not be helped. The Temperance Movement of the 1820s focused on negating drinking behavior. It made attempts at preventing consumption rather than dealing with alcoholism once it had occurred. The movement advocated temperance for everyone, whereby members made pledges of abstinence.

The rise of the Washingtonian Society in the 1840s brought a new idea in that a suffering alcoholic could be restored to a useful place in society. Six drinking buddies took their experience with the Temperance Movement and named the new organization in honor of the nation's first President. The new founders signed the following pledge:

"We, whose names are annexed, desirous of forming a society for our mutual benefit, and to guard against a pernicious practice, which is injurious to our health, standing, and families, do pledge ourselves as gentlemen, that we will not drink any spirituous or malt liquor, wine, or cider."

This comradery had drunks banding together to solve their drinking problem, and quickly grew to an estimated 400,000 members in just a few years. However, attempts at solving numerous societal problems, losing primary focus of helping alcoholics, and the lack of anonymity (at least one prominent spokesman's drunken behavior tarnished the Washingtonian's reputation) all led to the Washingtonian's demise. By 1848, the society had virtually disappeared. This society faded, but not before significantly changing the treatment of alcoholism by stressing 1) that an alcoholic is not a moral degenerate but can and should be helped, and 2) the importance of drunks helping themselves in their recovery.

This set the stage for later views of alcoholism treatment, including the Emmanuel Movement, the Peabody Method, the Oxford Group, and individuals, including Dr. Silkworth. These will be discussed next month.

#### **STEP TWO**

#### CAME TO BELIEVE THAT A POWER GREATER THAN OURSELVES **COULD RESTORE US TO SANITY**

In Step One we admit powerlessness over alcohol and that our lives have become unmanageable - Now what?

For some people, Step Two comes easy. Some people already have a Higher Power. Some may have believed in God but felt He let them down. For others, this step can be a stumbling block, such as those that don't believe there is a Higher Power for them at all. I fell into this latter category when I originally entered AA. I felt that after the life I had lived there was not a God for me. I had convinced myself when I was a child that I had ruined any chances of ever having any type of a relationship with God. If a Higher Power truly did exist, then why did He allow life to dump all over me?!?! God didn't love people like me (or so I thought), so how am I to come to believe anything? Right?!? On the matter of restore us to sanity... I was pretty much convinced

that I was born insane, so how could anything or anyone restore to me something that I never had? I thought for sure I was one of the ones doomed to die an alcoholic death because I didn't know how on earth to begin living life on life's terms, on a spiritual basis, much less

until I found one of my own that worked for me. I was told to keep it simple. It was suggested that I not drink, read the Big Book and call my sponsor. It was also suggested that I practice prayer and meditation until my prayers reached farther than the ceiling tiles. I was told to keep coming back to the meetings, even when I didn't feel like it. Most importantly, it was recommended that I not quit 5 minutes before the miracle. What Miracle was ever going to happen to or for me? I wanted to scream "Remember me"?!? I am the one who is doomed! These suggestions all sounded silly, ridiculous, and pointless at first. However, through these suggestions, God was planting seeds, that once watered, would start doing for me what I couldn't do for myself. By regularly attending meetings, I saw first-hand the change in people's lives and witnessed people's attitudes change to gratitude, all while I sat still without much growth of my

own. I listened to people say that on a daily basis they

believed and suggested that

I use their Higher Power

prayed for God's will in their life, and I saw that they seemed to have a next level of happiness that I didn't have or feel. These same people talked about how life was getting better every day, and how their worst day sober is better than their best day drunk. I wanted what I was seeing and

hearing. It was now time for me to truly get serious and decide if I was open and willing to believe in a Power greater than myself that could restore me to sanity too. What an Order!!! In Chapter 4, We Agnostics, it says that lack of power was our dilemma. Up to this point, all I had known was relying on me and my own instincts and power, which I once thought worked. As of late, my best instincts and power, or lack thereof, had always gotten me into trouble, and deeper in my addiction of alcoholism. I would hear people in the rooms say that God started doing for them what they couldn't do for themselves as soon as they quit fighting everything and everyone and started believing in a power greater than themselves. I also heard people say that we will intuitively know how to handle situations that used to baffle us when we stop drinking and start working the 12 Steps of Alcoholics Anonymous and practicing the principles in all our affairs, just as the Big Book promises. I had to remember that my best thinking and instincts brought me to

My sponsor pointed out to me the difference between AA and church. She said AA is a spiritual program that offers spiritual solutions to the disease of alcoholism, not a religion or religious solution to my alcoholic drinking. This was something that I needed to hear to help me to recognize and understand the difference before I could let go of my original objections, fears, beliefs, and prejudices.

have a spiritual experience that could combat my illness.

In meetings, I heard people share their own experiences and tell how they came to believe in a Higher Power. I heard all walks of life tell me how, after working Step Two, God started working in their lives in ways they could never have imagined. I asked as many people as I could about Step Two. I asked how I could possibly jump from just barely being able to breathe and walk through 24 hours without drinking to being able to believe in anything, especially something that I couldn't see, touch, or feel. Most of their answers were about the same. Several people suggested I believe that they

AA and that maybe my way wasn't the best or right way to continue looking at life or my place in it.

Don't over think this step. We constantly remind ourselves that the steps are merely suggestions. I was told once that this step was for self-awareness and recognizing that maybe there is something bigger than us out there. I heard people with my similar experiences, viewpoints, and prejudices share how they came to believe in a power greater than themselves, and slowly, my ears and mind started to open.

I was told by many within the fellowship that I could use my sponsor, or the rooms of AA as my Higher Power until I found a

Higher Power that worked for me. I was also told that my Higher Power would evolve as my sobriety and my faith evolved. As weird as that all sounded, in a strange way, it eased my mind and made me feel more comfortable about the whole thing. I liked hearing that I didn't have to have all the answers. I was already failing in the outside world, the last thing I wanted to do was admit my fear of failing at finding a God of my understanding!!

As I mentioned before, I still tried to figure out where I fit into the spiritual/religious spectrum; atheist, agnostic, believer, or former believer. I soon found that none of that

really mattered, and this was me just trying to stall or find a reason why this program wouldn't work for me. Now that I had admitted that I was powerless over alcohol, I needed to stop debating and find a way to stay away from alcohol before it killed me. I had to become willing to believe that only a power greater than I could do that for me and could also restore me, my life, and my soul to sanity.

This step doesn't have to be worked or understood 100 percent right off the bat. By beginning to seek out a Higher

Power for myself, having faith, and continuing to practice Step Two to the best of my ability, I started to see how making just a few simple changes in how I conducted my day

might someday find me restored to sanity; happy, joyous and free. It is my experience that more will always be revealed as long as I continue to seek God's will and work the 12 Steps of AA. I may not always know what God's will is for me, but one thing is for sure.... I know God's will is not for me to drink!! Sober living led me to the sunlight of the spirit and away from the darkness, gloom, and doom!

#### TRADITION TWO

There is but one ultimate authority, a loving God as he may express himself in our group conscience. Our leaders are but trusted servants, they do not govern.

The Second Tradition is all about spirituality-the spirituality of each individual and the spirituality of the group at large. It's about democracy, our own ideas of spirituality, and how our Higher Power shows up in the group. It is important that each of us have a reasonable idea of what our Higher Power is and what he wants for us before we can act as trusted servants. Governing is easy. Serving is a little more complicated.

Here are some ideas to ponder that I found on Silkworth.net:

- Do I criticize or do I trust and support my group officers and committees?
- Am I trustworthy, even in secret, of 12 step jobs or other AA responsibilities?
- Do I look for credit in my positions or praise for my ideas?
- Do I have to save face in my group or can I honestly share what is going on?
- Even if I have been sober for many years, am I willing to serve my turn with AA responsibilities?
- In group discussions, do I sound off about matters on which I have no experience or knowledge?

The first business meeting I attended, I saw little of group spirituality. I did, however, see parliamentary procedure, politeness, brisk discussion, and arguing. At that point in my recovery though, I didn't know to look for spirituality. I hadn't done enough reflection on my own spirituality. So, I stayed away, as many of us do. I told myself others were doing such a good job, I think I'll let them. I asked myself how I could let go of my desire to know what is right for the group at large. I am strong willed and opinionated. How can that work in a group?

Today, because I have a much stronger concept of my Higher Power, I can see my path more clearly and I am beginning to know how to serve. I look to my sponsor to guide me in that because I have learned not to trust myself with those important decisions. Maybe we can all look at our paths in sobriety to see where we need to step up, to carry the message, to help our AA program function and grow. We need to share responsibility in order to allow our program to thrive, not just exist.

The 12 Step List is a list of people that are willing and able to carry the message to the next suffering alcoholic. The 12 step list is provided to the 24/7 phone hotline coordinator and volunteers so they will know who to contact if they receive a call from a suffering alcoholic who needs help. If you are presently on the 12 step list, or if you are interested in being on the list, please attend the meeting.





#### **CONCEPT TWO**

When in 1955, the A.A. groups confirmed the permanent charter for their General Service Conference, they thereby delegated to the Conference complete authority for the active maintenance of our world services and thereby made the Conference—excepting for any change in the Twelve Traditions or in Article 12 of the Conference Charter—the actual voice and effective conscience for our whole Society.

Concept 1 gave final responsibility and ultimate authority to the A.A. Groups themselves, but how would the groups carry out the maintenance of the world services? It would be impossible. At the 20<sup>th</sup> Anniversary A.A. Convention in St Louis in 1955, the Conference Charter was confirmed and delegated these services to a General Service Conference—whose members include Delegates elected by each service Area (ours is Alabama/Northwest Florida). The Conference process is an interesting one when we look at it because it both listens and speaks.

The Delegates and other Conference members receive the agenda for the Conference which is then distributed to the groups (in our Area via the Alternate Delegate to the DCM to the GSRs then to the groups' members) and each has the opportunity to read, discuss and give input back to the Delegate (in our Area at a special Pre-Conference Assembly usually in April). The Conference convenes, listens, shares, then acts on each item and thereby achieves an informed Group Conscience (Tradition 2) of A.A. as a whole.

When I was new, I read a lot of the concepts wondering when they would actually apply to me, but I've learned that I begin practicing Concept 2 when I accept a position of trusted service at my group (the group delegates a

responsibility and authority to me). I show up to my service commitments, whether it is a district meeting, a committee meeting, or taking a meeting to an institution, then I bring back to my group any information gathered or action needed to continue carrying the message.

In case you're like me and key in on words like "excepting" I'm including a reprint from the Conference Charter, found on pages S103-S108 in the Service Manual to highlight what is necessary to make a change in the Twelve Traditions or in Article 12 of the Conference Charter. If you'd like more information—seek out your local General Service Junkie (I promise we're out here) and ask questions!

AND IT IS UNDERSTOOD: That neither the Twelve Traditions of Alcoholics Anonymous nor the warranties of Article XII of the Conference Charter shall ever be changed or amended by the General Service Conference except by first asking the consent of the registered A.A. groups of the world. [This would include all A.A. groups known to the general service offices around the world.]3 These groups shall be suitably notified of any proposal for change and shall be allowed no less than six months for consideration thereof. And before any such Conference action can be taken, there must first be received in writing within the time allotted the consent of at least three-quarters of all those registered groups who respond to such proposal.
